2. Vendors will keep all profits from sales at the event.
3. The event is rain or shine and no refunds will be given.
4. The festival is free and open to the public.
5. Alcoholic beverages are permitted for sale by the West End Alliance only.
6. Placement will be selected at the discretion of the event committee based on electrical needs and space requirements.
7. All vendors are required to supply their own tables, coverings, chairs, tent(s), needed equipment, supplies, promotional materials and signage.
8. If electricity is requested, vendors are required to bring their own lighting and heavy duty extension cords.
9. Vendors will have access to running water at the Fairgrounds fence on Liberty Street.
10. You agree to allow the West End Alliance, Inc. to use your business name and image in photos or in videos and grant permission to use this information in print and on social media without compensation.
11. The West End Alliance is committed to ensuring a varied representation of food vendors at the event.
