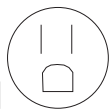
We are seeking vendors who provide a family-friendly activity to engage children of all ages at the festival.

2. Vendors will keep all profits from sales at the event, if applicable.
3. The event is rain or shine and no refunds will be given.
4. The festival is free and open to the public.
5. Placement will be selected at the discretion of the event committee based on electrical needs and space requirements.
6. All vendors are required to supply their own tables, coverings, chairs, tent(s), needed equipment, supplies, promotional materials and signage.
7. If electricity is requested, vendors are required to bring their own lighting and heavy duty extension cords.
8. Kids activity vendors are requested to remain until sunset, 7:00 p.m., and can choose to stay or leave after that time.
9. You agree to allow the West End Alliance, Inc. to use your business name and image in photos or in videos and grant permission to use this information in print and on social media without compensation.
10. The West End Alliance is committed to ensuring a varied representation of vendors at the event. Although this is not a juried show, we will be unable to accept multiple vendors in the same category.
